An applicant must have current direct involvement in one of the primary disciplines of commercial real estate. "Current direct involvement" means that such person (a) is currently working in and is actively engaged either exclusively or primarily in commercial real estate (i.e., all or most of such person's gainful employment or major source of income is in commercial real estate), and (b)(i) is involved in promoting and contributing to the financial well-being of a company, (ii) is in a managerial, senior level, professional, or revenue-generating position or capacity within the company, (iii) is in a decision-making or decision-influencing position, or (iv) otherwise participates at a professional level in a qualified field of commercial real estate.

Full Member: Any professional meeting the above criteria is eligible for full membership.

Affiliate Member: Any person engaged in a profession or business related to commercial real estate but who does not meet the qualifications for a Full Member but provides a service or product to the commercial real estate industry.

Note: Membership is on a calendar year basis and must be renewed annually. New member applications accepted in the 4th Quarter of the calendar year will be processed for the following calendar year. Membership in CREW stays with the individual and cannot be transferred.
